

## Plain Language Summary of Financial Assistance Policy

Kennedy Krieger Institute provides financial assistance for medically necessary care to eligible individuals and families on a sliding scale based on financial need. Two types of assistance are available, and information about eligibility, applying, and where to find more information is provided below.

You may be eligible if you reside in the United States and meet the following criteria:

	Medical Indigency	Catastrophic Assistance		
	Patient is a beneficiaries/recipients of a social service program (WIC, SNAP, etc) <b>OR</b>	Household income is more than 400% of the Federal Poverty Guideline Medical bills more than 60% of household income		
	Household income is less than 400% of the Federal Poverty Guideline			

**Determination of Assistance:** Assistance is awarded for Medical Indigency and Catastrophic Assistance as outlined below.
